

April 12, 2022 – Village Board Meeting Minutes 7:00 pm – Casco Village

Tim made a motion to approve the agenda Francis 2nd (7 pm); All board members present: Troy Alsteen, Dennis Cravillion, Francis Gilson, Tim Kinnard, Kelly Pinchart – President, Tammy Skarban-Clerk

Tim Kinnard and Chad Cochart were sworn in as the Village Trustees from the April election (7:02 pm)

- **Residents Concerns:**

- Duane Opicka read a statement on behalf of Nathan Kollross concerning the possibility of removing the stop sign on West Ave and 1st Street
 - It's been there 16 years
 - Isn't hurting anything staying; except slowing people down
 - Got 27 signatures of residents and parents of daycare children
- Brandi Kollross said she feels it's safer for walkers and kids to use 1st Street instead of walking on Main Street
 - There are a lot of small kids and walkers on that street everyday
- Tim Kinnard said: "no one on the Board ever said we were going to remove the stop sign" (7:14 pm)

Updates from Bruce

- **DOT** estimate for the parking lanes is now \$85,267
- Lawn mower – Lemens Hardware didn't have any, Luxemburg Implement has 2
- Manholes on they highway have all been fixed (1 need more repair than expected)
- Last Wednesday was the 2% Dues Audit – we passed but they want to see the bi-laws and the firemen need to some more training on reports
- Refrigerator in the fire garage died last week so if anyone is getting rid of one, let Bruce know
- April 30th is the Ugly Purse Auction for the Fire Department at Rendezvous
- Sewers were flushed Monday, April 11
- **If it's not toilet paper, it doesn't go down the toilet**
- **Please do NOT put grease or wipes of any kind down your toilet or drains!**
- DOT was going to put a handicap ramp at the post office, but revised the plans so it isn't taking up the entire front of the building
- DOT said the curb has to remain at the gas station because of DOT regulations for the size of a driveway on a highway (7:36 pm)

Land and Water Update:

- **No** results from the study are back yet
- The Daycare is in "administrative order"
- Free water tests will be available in July and November. All residents are encouraged to contact the Land and Water office to be added to the list. 920-845-9740 (7:57 pm)
- Minutes were approved as presented, Francis made the motion to accept, with Dennis 2nd the motion – all approved (7:37 pm)
- Bills were presented, Dennis made a motion to approve, Troy 2nd the motion, all approved (7:44 pm)

New Business

- **DNR** asked for an extension to approve the plans for the sewer plant that were submitted
- Tim made a motion to keep the stop sign on 1st Street (West Ave) Troy 2nd, all approved, motion carried (7:59 pm)
- Tim made a motion to order the new lawn mower with double bags from Luxemburg Implement for \$8367.95. Francis 2nd, all approved, motion carried (8 pm)
- Cory Cochart took care of the water issue in the subdivision; looks good (8 pm)
- Bug Tussel sent our fliers stating they would be coming "through" the Village. They are going down C (Church Ave) and then left onto Hwy 54 only. We have applied for a grant from NSight and they will go through the entire Village and offer more services for less money (8:08 pm)
- Lisa Cochart is planning for Christmas; she is going to see if the reindeer will be available on December 4th from noon – 2 pm and the Village will be donating (8:13 pm)
- Meg Kline is getting the paperwork started for the land purchase
- St. Louis Parish is holding a recycling event on Wednesday, June 1st from 1-5 pm

Old Business

- Board of Review will then be held on May 10th if issues are not resolved (must have an appointment)
- Tim made a motion to adjourn with Francis 2nd the motion (8:38 pm)
