Land and Water Update:

- 20 extra samples were taken from Village for extra test

- Everybody north of Casco Creek had trace of agricultural waste in well test
 - No Health Concerns
- Nitrates are still high but numbers are trending down
- Testing is being conducted again this week (test pickup Thursday and Friday)
- We will continue to talk to neighboring farms asking them to continue to cooperate in not spreading liquid manure & fertilizer
- 2 wells had a "human hit" in new subdivision (televise lateral immediately)
- Might have to adjust sludge spread
- Lawn care isn't really affecting our wells

- Testing will continue twice a year
- Future land and water meetings will be in the morning in November and December but the January 17th meeting will begin at 5 pm with the well testing information meeting at 6 pm at the Kewaunee County Fairground Expo Hall in Luxemburg; everyone is welcome and encouraged to attend. 7:47 pm

- We will be charged an additional \$11,000 in 2025 new ambulance.

Fiber

- Nsight is looking at a completion date of 12/31/23 for the entire village
- Bug Tussel also came through and if there are still issues, call the County Administrator's office so
 they can put together a punch list and have them address the issues

Building Inspector: Brett Guilette doesn't want to be our zoning administrator any longer but will continue with the building permits as the building inspector.

There is a "utility right away", an alley way that was created years ago behind the residents on the west side of West Ave. The county said it was done this way for a reason. The residents that live there maintain the right of way just as any other resident does, they want the extra property to be put into their names. The Village will not pay for any legal paperwork to change the land over and doesn't feel it needs to be changed.
