- Chicken Ordinance we will change wording to "NO CHICKENS ALLOWED"
 - Dan/Chad made motion to change verbiage 6:59 pm
- Parking Ordinance we will change wording to allow overnight parking except from Nov 1 April 1
 - Dennis/Chad made a motion to change verbiage 7 pm (Tammy will get contact information to order new signs for the Village)
- LRIP Northeast Asphalt gave us a bid for 580 ton at \$56.70/ton. Chad/Dan made a motion to accept NE Asphalt bid 7:10 pm (Tammy will send back paperwork and Troy will contact Kewaunee County)
- Luxemburg Rescue will be getting a new squad in 2025; all municipalities will be charged for the cost
- Lions put \$20k into a CD for park improvements; which is new lighting, WPS will drill into the existing poles to see if they can be used or need to be replaced. Troy will be coordinating with students from NWTC

along with the company from Kewaunee to set the lights if this is something the Village Board wants to pursue, then the money from the Lions would be used. 7:17 pm

- Lisa Cochart attended the Land and Water meeting. She asked about a "Grant Writer" to help Kewaunee County with their water issues. She felt that if we had a specific person to write the grant with the correct wording, maybe that would help generate money for out county. 7:24
- Christmas in Casco is scheduled for Saturday, December 7th
- Trick or Treat in Casco Village will be Sunday, October 27th from Noon 2 pm

Old Business

- Keep your yards clean and grass cut we want a nice-looking Village
- Any business on a residential lot will have to be rezoned.
- Fire rating is now 5 for homeowners' insurance effective 8/1/24. Great job Bruce and firemen!
- Citation ordinance went into effect May 22nd, all residents were mailed a copy with sewer bill.
- LRIP is for overlay for Burke/Hyland. The cost is \$50,000, we will receive \$14,383.51 when we spend \$35,616.49
- Some of the chairs need to be replaced in the hall. We will have to work that into next year's budget plan.
- We are going to have to have a full Village wide revaluation, according to the state since we are below the 80% ratio. Our assessor is holding off until 2026.
