- Please try to pay your Sewer bill on time. They are due on the 10th of the month following the quarter end (Jan 10, April 10, July 10, Oct 10). This is a Utility bill just as your Public Service bill and should be paid on time. Any bills not paid by October 28th will be added to your taxes with a 15% penalty. Anything added to your taxes is due with your first payment, however the Village doesn't receive the money from the County until our August settlement. This means we have to come up with the money to pay the bills from other resources
